EMPANELMENT OF VALUERS IN SBI NORTHEAST CIRCLE

State Bank of India, North East Circle, Guwahati, having its jurisdiction over all seven states of North East, invites application from Professionals/Valuers for their Empanelment in State Bank of India for valuing financials assets i.e. **Land and Building/Real Estate, Plant & Machinery, Securities or Financial Assets, Stocks (Inventory) & Shares (under Wealth Tax Act), Agriculture Land (Plantations & other than plantations), Jewelry & Works of Art till 15.02.2026** and subject to annual renewal thereafter.

Entities eligible to be appointed as banks valuers are Individuals, Partnership Firm registered under the Indian Partnership Act 1932, Limited Liability Partnership Firm (LLP) and Company Incorporated in India.

A person shall be eligible to be empaneled as a valuer if he has completed 25 years and no upper age limit for continuing as a valuer on the Bank's Panel. Valuer shall be a member of any one of the authorized/ accredited institutions viz **IOV, IESMA, PVAI, ICSI, IIV, ICAI, ACVA, CVSRTA, CEV, Council of Engineers and Valuers, Divya Jyoti Foundation** or any other association registered as RVO with IBBI and possess qualifications as detailed and have satisfactory CICs reports from CIBIL, Experian, Equifax, CRIF etc. and are credit worthy. The valuer undertaking and ascertaining the valuation of asset, **under SARFAESI Act, 2002, must be registered under Sec. 34AB of Wealth Tax Act, 1957** and have completed at least 5 (five) assignments successfully as valuer during immediately preceding 12 months. They must submit at least three reference letters, either from Bank Managers where valuers had done valuations, or from a company on their letterheads for whom they conducted valuations. However, if a valuer has already been registered with our Bank for the past 3 years with impeccable track record, there is no requirement for a reference letter during the renewal of empanelment of the valuer. They must be possessing minimum work experience in undertaking valuations for their classification by the bank, which will be calculated from the date of his/her first empanelment with any Bank/Financial Institution/High Court or registered under Wealth Tax Act' 1957.

The detailed eligibility criteria and application forms and other formats can be obtained from **the Regional Business Office (RBO)** of the bank located at different parts of the Northeastern States. They need to apply in prescribed format with relevant enclosures/ documents etc. to RBO with 7 days from the publication of the advertisement, who will be completing required due diligence on such applications and forward the same to the appropriate authority for consideration. Details of education qualifications and desired experience can be obtained from the Regional Business Office of the Bank.

It should be noted that this is only an invitation of offer for the interested professionals/valuers, and the Bank reserves the right to select or reject any offer without assigning any reason whatsoever. Terms and conditions regarding offering assignments and payment thereof will be determined at the time of offering assignments to the empaneled valuers.
