NOTICE: Call Option of Additional Tier 1 Bonds of ₹4,000 crore issued on 03.09.2021, Coupon @ 7.72% Per Annum (ISIN- INE062A08280)

In terms of the Placement Memorandum dated 01.09.2021, Non-Convertible, Taxable, Perpetual, Subordinated, Unsecured fully paid-up Basel III compliant Additional Tier 1 Bonds aggregating to ₹4,000 crore (coupon @ 7.72% p.a.) were issued by the Bank under private placement, with a call option on the principal amount outstanding. The call option may be exercised by the Bank at its sole discretion on the 5th anniversary of the Deemed Date of Allotment, subject to prior approval of RBI.

2. Accordingly, notice is hereby given to the Bondholders that the Bank has decided to exercise call option on the Non-Convertible, Taxable, Perpetual, Subordinated, Unsecured fully paid-up Basel III compliant Additional Tier 1 Bonds (INE062A08280), on the call option date i.e., **03.09.2026**. In this regard, RBI has granted permission for exercising call option of the bond series vide their letter dated 15.06.2026.

3. Further, in terms of the Placement Memorandum:

- a. The principal amount together with interest for the period from 03.09.2025 to 02.09.2026 will be paid on 03.09.2026, and the Bond will not carry any obligation from the said call option date.
- b. The 'Record Date' for payment of call option amount along with last interest due will be 19.08.2026.
- c. The Bonds held in dematerialized form shall be taken as discharged on payment of the redemption amount by the Bank on exercise of call option to the registered Bondholders whose names appear in the Register of Bondholders on the Record Date. Such payment will be a legal discharge of the liability of the Bank towards the Bondholders. On such payment being made, the Bank will inform NSDL/CDSL and accordingly the account of the Bondholders with NSDL/CDSL will be adjusted.
- d. The payment will also be subject to the terms contained in the Placement Memorandum.
