ANNEXURE -I**1. BRIEF DESCRIPTION OF THE PROJECTS**

SBI is going to recast the list of empaneled contractors of different trades and category. Accordingly , Press advertisement & notice has been published on 05.05.2025. All the application to be received are to be scrutinized for preparation of panels of different trades and category.

2. SCOPE OF WORKS AND TERMS & CONDITIONS

The architect shall render the following services in connection with and regarding the said works:

- a) **The said work will be carried out at our office and in presence of Concerned Bank Officials.**
- b) Numbering of the applications to be received category wise and trade wise.
- c) Opening of the offers and get the applications signed by the Tender Opening Committee formed at our level.
- d) Enter the required Data and Prepare the Spread sheet as per the enclosed format in Excel form for each category and each trade separately. For the said purpose, the Hardware, Stationary etc. will be provided by the Bank.
- e) The representative of the firm, who will execute the work should be Technically qualified. Fresh Graduate Or Diploma in any Discipline will serve the purpose.
- f) Preparing pre-qualification document, scrutinize the applications for empanelment of the contractors, recommendations to the Bank for empanelment of the contractors (to be submitted in form of two hard Copies with a soft copy).
- g) Assisting the Bank in all Legal proceedings between the contractors and the Bank and also defend the Bank in such proceedings.
- h) Rendering any other services connected with the works usually and normally rendered by the architect but not referred to herein above.
- i) To obtain the confidential report from the clients/SBI Branch Managers of the Contractors, to obtain credit opinion/ Solvency of the Contractors from the Bankers and to verify the work executed by them.
- j) GST Registration Validity, GST Return done (Updated) to be verified from Govt. Portal.
- k) Income Tax Registration, Income Tax Return done (Updated) to be verified from Govt. Portal.

3. Agreement with Bank:

The architects shall enter into an agreement in a non-judicial stamp paper with the Bank as per Bank's standard format. In case it is established that due to the fault of the Architect , the Bank has to pay any extra amount due to overrun of the work or any other lapse on the part of the project architect, necessary recovery may be effected from the project architect's fees as per provisions of section 73 of Indian Contract Act 1872 under section 30 of Architect's Act 1977(Central Act No. 20 of 1972) and / or project architect may be debarred from employment for specific period and / or blacklisted depending on the gravity of the lapses of the project Architect.

4. Method of fees payment:

The Bank shall pay fees to the Architect in the stages as follows:

(a)	After completion of numbering and get the applications signed by the Tender Opening Committee of the Bank.	1/8 th of the total payable fees.
(b)	After completion of Tabulation of DATA as per the prescribed format for pre-qualifications of contractors.	3/8 th of the total payable fees.
(c)	After preparation of final contract's pre-qualification documents including obtaining the confidential report from the clients of the Contractors, to obtain credit opinion from the Bankers.	3/8 th of the total payable fees.
(d)	After expiry of cooling period of 12 months from the date of completion of the job.	1/8 th i.e. 100% of the total payable fees.

6. Basis of payment:

The consultancy fees shall be paid based on Total Fees Payable of the said work.

7. Method of selection of architects:

Based on the lowest fees quoted as per the price bid enclosed, project architects shall be considered for appointment. Bank reserves the right to reject any or all tenders received without assigning any reason thereof.

7. All the pages of the tender document are to be signed by the authorized signatory.
