S.No	Category	Description of category
1	DG-I	EMPANELMENT OF VENDORS FOR HIRING OF DG SET FOR CAPACITY (5- 62.5 KVA)
2	DG-II	EMPANELMENT OF VENDORS FOR HIRING OF DG SET FOR HIGHER CAPACITY (82.5-250 KVA)

Individual person / Firm may apply in single application for two category, however it is necessary to mention in application form that firm applied for both category and work orders to enclosed as per above criteria. If any firm found eligible for higher category DG-II eligible, that shall be considered eligible for DG-I automatically.

2. While deciding upon the empanelment of Firms/ Individual, great emphasis will be given on the ability and competence of applicants to do good quality works within the specified time schedule and in close co-ordination with Bank as well as other agencies.
3. Decision of the Bank in regard to selection of Firms/ Individual will be final. The Bank is not bound to assign any reason for acceptance/ rejection of any applications.
4. Each page of the this notification should be signed and shall be uploaded online. The application shall be signed by persons/ persons on behalf of the organization having necessary authorization/ Power of Attorney to do so (Certified copies to be enclosed).
5. If the space in the proforma is insufficient for furnishing full details, such information may be supplemented on separate sheets of paper, stating therein the part of the performa and serial number. Separate sheets shall be used for each part. **However, the format shall be as per performa.**
