### Reason for shifting:

- 1) The existing premises is 50 years old, and the lease agreement has been expired on 31.05.2025. The landlord has given eviction notice dated 19.04.2025 (Annexure B) to vacate the premises and has shown unwillingness for further negotiation and renewal of lease agreement.
- 2) The current rent rate of the branch premises is approximately Rs13/-per sq.ft for the total carpet area of 2,600 sq.ft. The prevailing rent rate of various shops located in the market is around Rs 67-68/-per sq.ft (letter from RBO -I Kanpur **Annexure C** enclosed).

3) Shifting to a new place is necessary on an urgent basis to provide uninterrupted banking operations to our customers and will help in providing better customer service and experience to our valuable customers.

On account of above-mentioned reasons and Module's recommendations, the existing premises of Kalyanpur branch may be shifted.

- 2. We have examined the proposal and are of the view that
  - a) The power to approve shifting of the Branch premises is vested with the Circle Management Committee as per Memorandum for the executive Committee of Central Board, Sec-23 of the Banking Regulation Act-1949 Delegation of Authority dated 27.07.2015 (Annexure D).
- 3. In view of the above and as recommended by the DGM (B&O), AO Kanpur, we propose that 'In Principle' approval for shifting the branch may be granted.
- 4. The validity of "In Principle" approval will be 1 year from the date of approval.
- **5.** After approval for shifting of the branch is accorded, we shall advise DGM (B&O), AO Kanpur & Regional Manager -1, Kanpur to ensure:

  - d) Serving proper notice to the existing landlords of the branch.
  - e) The proposed new branch to be identified on the ground floor with Ramp facility, having dual connectivity and Commercial license from the local authorities for running banking activity in the premises.
  - f) The branch is shifted in the new premises within 1 year from the date of approval.
