### Description of Work:

The proposed work involves supply, installation, testing, commissioning & maintenance of **On-Grid Solar Roof top Power Plants of capacity ~10kWp** for the above-mentioned **Bank's own Building**. The work involves site study, design, supply installation testing and commissioning of: On-Grid Solar power plant – Solar PV **module (545Wp and above – mono-crystalline half cut)**, module mounting structure, DC-DB, AC-DB, Grid tied Inverter, AC DB, Solar Generation Meter, Bidirectional meter as per DISCOM requirements, Obtaining necessary approvals from DISCOMs/ Inspectorate, Necessary cable and wires as per standards, lightning arrestors, its associated works, etc. The vendor should work in tandem with the Consultant Civil, electrical vendors involved in the same project.
