NOTICE INVITING TENDERS FOR DISPOSAL OF E-WASTE

The State Bank of India, Global IT Centre, Belapur, Navi Mumbai invites bids through GeM portal from authorized Recyclers / Reusers / Refurbishers of e-Waste. The Recyclers / Reusers / Refurbishers should be authorized by State Pollution control Board or Pollution Control committee as per the guidelines of the Central Pollution Control Board for disposal of e-Waste.

The old/obsolete material (e-Waste) list (Annexure-I) including old/obsolete computer, keyboards, laptops, printers, cables and peripherals and other items on "as is where is basis". There is no fee for Tender documents. Manual bids shall not be accepted. Important date of tender-related activities is as under: -

EMD is mandatory to be eligible for all the bidders.

3. Eligibility:

- Valid authorized certificate from the State/Central Pollution Control Board, dealing with e-Waste (minimum valid till 31.03.2027).
- GSTIN in the name of the unit/firm of the bidder.
- PAN in the name of the unit/firm of the bidder.
- Proof of EMD amount deposit for all bidders (including MSME and Udyam Registration certificate holders).
- The unit/firm must be audited in last financial year (i.e.2024-25).
- The unit/firm must process the e-wastes of any Commercial Bank once in last 3 years.
- The unit/firm should not have any penalty or pending action initiated by the Pollution control Board.

4. The Earnest Money of EMD in respect of tender must be deposited in the said account on or before the last date and time of submission of pre-qualification document i.e. by 08.06.2026: 05:00 PM). Non-submission of original payment instruments like EMD shall lead to rejection / disqualification of the tender.

(a) EMD of remaining Bidders, except of the qualified bidder, shall be returned after the completion and successful Bidding process and awarding the work to the qualified bidder.

(b) The EMD of the successful bidder shall be returned after the completion of all work and submission to all required certificates.

(c) No interest shall be paid on EMD.

(d) EMD shall be forfeited, in any of the following cases: -

(i) The bidder withdraws its proposal after the tender due date.

(ii) The successful bidder fails to accept LOA within the stipulated period.

(iii) The successful bidder fails to provide all the required certificates within the stipulated period.

5. Minimum Reserve Price for the Bid will be Rs.1,38,00,000/- + GST as applicable (Rupees One Crore Thirty-eight Lacs Only Plus GST as applicable). Price quoted below the reserve price will not be considered for award of work / auction. The auction process will be in accordance with all terms and conditions guided by the GeM portal.

6. Bids shall be submitted at GeM portal only. Bidders/Vendors are advised to follow the instructions provided on GeM portal.

7. Bid documents may be scanned with 300 dpi with black and white options which helps in reducing file size of the scanned documents.

8. Bid will be opened as per date/time as mentioned in the GeM portal.

9. Bank may cancel ANY or ALL the bids if it is not found to be fulfilling any of the above condition(s).

10. Bank reserves the right to accept in part or in full or reject the entire bid and cancel the entire tender without assigning any reason there for at any stage.

11. Bank does not bind itself to accept highest or any of the bid.

12. Bank does not make any guarantee of quality of articles available to the buyer.

13. Ensure that all e-waste collected from the Bank should be recycled/dismantled/refurbished.

14. The lifting of the items shall be done without damaging the premises / roads / drains / etc. The buyer shall compensate for the damages, loss, etc., in the event of any occurrence otherwise.

15. No selection or sorting whatsoever of the goods will be allowed. The entire lot should be cleared by getting proper Gate Pass.

Terms and Conditions of the Tender

1. Prospective bidder should submit/upload following documents for pre- qualification on GeM portal mandatorily:

(i) Bidders must upload the copy of PAN, GST No, audited balance sheet (2024-25) and E-waste Dismantling authorization Certificate / authorization from pollution control board and duly filled along with bid in the GeM Portal. In case the uploaded documents are not readable or the bid cannot be examined, the Bank reserves the right to reject the bid of that firm.

(ii) The bidder should have valid authorization from pollution control board (up to 31.03.2027) and submit copy of the same along with the bid. Bid without valid authorization letter from P.C.B. will be treated as invalid & will not be considered. The original copy of such certificate should be shown to the Bank as and when demanded. Bidders also submit by mode of affidavit as the unit/firm should not have any penalty or pending action initiated by the Pollution control Board.

(iii) Tender Document to be signed and stamped by the vendor/bidder and scanned copy to be uploaded in the GeM portal. Signed and scanned copy of valid registration certificate, PAN, GST No, audited balance sheet (2024-25) and Tender acceptance letter.

(iv) Annexure II, III, IV & V duly signed & stamped.

(v) Proof of the unit/firm processed the e-wastes of any Commercial Bank once in last 3 years.

(vi) Proof of remittance of EMD.

1.1 Bids are invited only from the authorized Recyclers/Reusers/Refurbishers of e-waste having valid authorized certificate from the State/Central Pollution Control Board, dealing with e-Waste. The bids received from other firms / vendors/ recyclers other than, authorized by State/Central Pollution Control board, will be summarily rejected.

1.2 The e-Waste should be removed by the successful bidder on “as is where is basis” within 15 days (only in the office hours between 11:00 A.M to 5:00 P.M) from the acceptance of intimation letter and deposit the full amount within 7 days from acceptance of the intimation letter by way of transfer or through NEFT/RTGS in account number:

The EMD shall be returned after e-Waste is removed and submission of all required certificates within the prescribed time. The Earnest Money will be forfeited and any loss/damage to the “SBI or third party whatsoever” during collection/shifting will be recovered from the bidder.

1.3 The intimation letter must be accepted by the H-1 bidder within 3 days otherwise the EMD amount will be forfeited. The H-1 bidder shall deposit 100% of the final bid amount in above said account number within 7 days of final bid. The H-1 bidder may start (if interested) the process of degaussing after depositing 25% of the finalized amount and the rest 75 % of finalized amount must be deposited within 7 days of final bid. The E-WASTE purchased by the bidder should be collected within 15 days of accepting intimation letter. The collection and

disposal of the same shall be removed by their own means (Vehicle and Labour etc.) from our site during office hours between 11:00 A.M to 5:00 P.M. only.

1.4 The inspection of the Material should be done carefully by the prospective bidders OR their representatives at our office between 11:00 A.M to 5:00 P.M. on dates as per the GeM portal and queries raised to the concerned officer at the time of inspection. No further clarifications shall be given after the above inspection.

1.5 No damage should be caused to the existing property of the “State Bank of India” or the Govt. while removing the e-Waste from the sites. Any loss/damage to the “State Bank of India”, third party or injury or personal accident suffered by any person due to negligence or action of the successful bidder or his representative will have to be indemnified by the successful bidder.

1.6 The E-Waste will be removed under the supervision of designated officer(s) of the ‘State Bank of India’. The e- Waste will have to be removed with in time stipulated in the order issue awarding disposal of e-waste to the successful bidder. No extension of time will be given under any circumstances.

1.7 All the bidders shall ensure compliance with the provisions contained in e- Waste handling guidelines issued by the Government, from time to time for its disposal/recycling in an environmentally friendly manner.

1.8 The State Bank of India reserves the right to accept or reject any or all the tenders without assigning any reason.

1.9 The successful bidder shall have to furnish an affidavit that the material will be sent to the factory for recycling/dismantling/refurbishing only and shall not be disposed of in any other manner whatsoever.

1.10 The successful bidder of electronic items, at the time of delivery shall give an undertaking that the disposal of these items will be strictly as per norms/ rules laid down by the Government of India and the following “e-waste certificate” will have to be given by the successful bidder of the auctioned equipment as per the timeline.

Scope of Work :

This tender pertains to the disposal of obsolete, unserviceable, electronics & electrical equipment etc. classified as e-waste, accumulated by State Bank of India, GITC, Belapur, Navi Mumbai. The items listed for disposal include but are not limited to desktops, laptops, printers, scanners, photocopiers, UPS units, monitors, server, cables and peripheral accessories, etc. E-waste disposal shall be in the presence of officials from Estate Department, System officer and Security supervisor. The successful bidder shall:

1. Collect, transport, and dispose of the e-waste materials from the designated site(s) on a basis as is-where-is.
2. Ensure compliance with all relevant environmental laws and guidelines issued by the Central/State pollution Control Boards concerning e-waste recycling and disposal time to time.
3. Provide all necessary manpower, tools, transport and documentation required to carry out the disposal activity in a safe, efficient, and environmentally responsible manner.
4. Submit appropriate recycling/disposal certificates for all collected items within the stipulated times as mentioned earlier.
5. Complete the lifting of materials within 15 working days (Only in the office hours) from the date of issue of work order/auction award.
6. Bear full responsibility for any damage caused to Bank's/government property during the collection or transportation process.
7. Ensure the site is left clean and free of debris post-disposal.
8. Bidder must ensure the degaussing of data storage devices which are identified as e-waste and hammering of data storage devices before lifting the items from premises and must provide the certificate of the same.
9. Any claim irrespective of nature or raised by any local unions will be handled by the bidder at their own.
