c. Electrical Auditor must complete the safety audit as per the L1 rate during the 2.5 months' time duration. The bank reserves the right to reduce the completion time if the number of allotted branches is less.

TERMS AND CONDITIONS

1. The no of branches mentioned below is tentative.
2. After rate standardization the lowest rates will be advised to SBI RBO & Branches other outfits at under the geographical area of Administrative Office Kozhikode and work orders will be issued from AO/RBO as per the predefined ratio mentioned in the tender.
3. Successful vendors should be prepared to execute the Electrical audit at the agreed rates as and when orders are placed during the validity period of the tender
4. The tender rates shall be valid for a period of 6 months from the date of opening of the tenders.
5. In the event of a discrepancy between the rates quoted in words and the rates in figures, the rates quoted in figures shall be taken into consideration.
6. All pages of the tender document shall be signed by authorized signatory and stamped.
7. All corrections shall be duly signed and stamped. Bids received after the above stipulated time will not be considered.
8. SBI reserves the right to reject the offer without assigning reason or whatsoever.
9. **SBI reserves the right to distribute the work among L1, L2, L3 and L4 vendors in the ratio of 50:25:15:10, subject to the respective vendors agreeing to execute the work at the L1 quoted rate. In case only three vendors among L1/L2/L3/L4 agree to match the L1 rate, the work may be distributed in the ratio 50:30:20. In case only two vendors agree to match the L1 rate, the work may be distributed in the ratio of 60:40. The decision of SBI regarding distribution of work shall be final and binding.**
10. Please enclose the list of technical staff with contact addresses and telephone numbers.
11. Conditional tenders are not acceptable.
12. The Electrical safety auditor or firm must arrange for the conveyance, lodging expenses, men and material required for conducting the safety audit at their cost.
13. Adequate care should be taken by the electrical auditor during the verification, measuring and recording of the data.

14. Any damage to the Bank's property, equipment's under testing and measurement during the electrical fire safety audit will be charged to the firm.
15. The bank is not responsible for the accidental injury of any of the operating personnel involved in the audit procedure. Personnel should be well trained and should have adequate knowledge of electrical safety and handling of electrical equipment.
16. All the rates quoted against each category as per the Price bid format in Annexure D must include Conveyance, lodging expenditure required for men and material. GST will be paid extra as per the actual.
17. The audit report must consist of all connected equipment details as per Annexure – B, layout drawing (not to be scale) of the branch premises showing the bifurcation of the areas such as BM Cabin, banking hall, UPS Room, Locker Room, Strong Room, Dining hall etc. along with location of major electrical equipment, MSB, DBs, UPS, ATM etc. Single Line Diagram (SLD) of existing electrical systems (from energy meter to sub DBs such as LDB, PDB etc.
18. **The Electrical auditor must submit four copies of audit reports to the respective Branch, Regional Manager (RBO Calicut), Chief Manager HR (Administrative office, Calicut) and Assistant General Manager, Premises & Estate (SBI), LHO. 19. The work shall be considered as complete only after submission of hard copy of the Electrical Safety Audit Report (As per Annexure B) to the respective Branches/ Offices & RBOs and submission of soft copy of the Electrical Safety Audit report at P & E Department at LHO Thiruvananthapuram & electrical Engineer at AO.
20. After the completion of Electrical Audit, the visit and Electrical Audit report with the acknowledgement of the Branch official, Invoice shall be submitted to the Office of SBI AO, Calicut for forwarding to respective Regional Office of SBI for the payment.
21. The copy of the contact number, ID card and authorization letter of the auditing person(s) must be submitted to SBI RBOs/AO well in advance for necessary co-ordination. Shutdown required if any may be intimated to branch in advance. **Staff without proper qualification will not be allowed to conduct safety audits.**

23. Upon the non-successful submission of report in required format in 4 copies, the bank reserves the right to reduce the fees payable to the vendor.
24. Overwriting should be avoided, and all corrections should be duly signed.
25. No inconvenience should be caused to staff/customer during working hours
26. SBI reserves the right to allocate any region or branch as per their requirement of SBI Administrative unit, Calicut, to the Empaneled electrical Auditors at the L1 rate.
27. SBI reserves the right to cancel the work order issued to the Safety Auditor at any stage in the event of failure of non-response, non-commitment and Non completion of the assigned task as per tender terms and conditions.

SCOPE OF WORK FOR ELECTRICAL SAFETY AUDIT

- a. Physical inspection of the Bank premises with reference to applicable Indian standards, Indian Electricity Rules and other relevant codes of Practice & identifying electrical fire hazards (shocks, fires, etc.) as per Kerala Electrical Inspectorate and KSEB Ltd Guidelines.
- b. Review of protection devices such as MCCB/MCB/ELCB system of the electrical installation and whether the performance is satisfactory or not.
- c. Review of adequacy of Wires/Cable sizes based on actual load current measurements, Insulation resistance, tightness of terminations.
- d. Review of electrical accidents to identify root cause of the accidents, if any happened review the EPM (Electrical Preventive Maintenance) program if any, in the Bank Premises to suggest recommendations as per applicable standards.
- e. To evaluate the earthing system (installation and maintenance) in the plant based on IS 3043 and to suggest recommendations including the measurement of Earth resistance.
- f. Check for any loose contacts at the mains switches, DB, Switch boards etc.
- g. Inspection of UPS and batteries for its adequacy in the capacity for the load requirement of the branch.
- h. Reliability of the electrical distribution system with the equipment's like air conditioners, UPS's, Generators etc. Checking whether the AMC of these items is in place.
- i. ***Evaluating whether the demand load is within the sanctioned load with proper load balancing.***
- j. Verification of the operation of system room Air conditioners with timer mechanism.
