5. Envelope-II shall contain price bid only

9. The quotation shall remain valid for a period of 90 days from the date of opening.

Quotation Terms & Conditions

1. 95% payment shall be released within 07 days after satisfactory execution of the work and remaining 5% will be kept as retention money and the same will be released after completion of 3 months from date final bill payment.
2. Work is to be completed on priority within 10 days from award of work date otherwise a penalty @ 0.5% per day of the contract value will be applicable to the maximum of 5% of contract value.
3. Bank reserves the right to reject any or all Quotation without assigning any reason.
4. The scope of work can be reduced or increased as per bank's requirement and the L-1 bidder must have to execute the work at the L-1 quoted rates for varied quantity.
5. The Quotation shall be submitted in the double envelopes - Envelope-I consisting of terms & conditions and EMD of Rs. 2,000/- and Envelope-II consist of price bid. Both envelopes should be super-scribed as **"Quotation for S.I.T.C of C.T in O.C.B Panel in A.O, Panchkula Building"**
6. The work will be executed in the presence of bank staff or staff assigned by the bank.
7. The rates include cost of S.I.T.C of transformer removing & re fixing existing transformer, transportation charges, any other accessories, tools required to complete the work. No compromise will be done in quality of the work.
8. Vendor to ensure that bank's property may not damage while executing the task.
9. The liaison with electricity department required to execute the work is to be carried out by the Vendor whom the work is allotted.
10. The contractors/bidders are advised to visit the site before quoting the rates.
11. **Arbitration Clause:** Any dispute and difference of any kind whatsoever, arising out of or in connection with this RFP or carrying out of the services, shall be settled amicably, if however, the parties are not able to resolve any dispute or difference amicably, the same shall be referred for arbitration in accordance with the provisions of Arbitration & Conciliation Act 1996 and re-enactment(s) and or modification(s) thereof and of the rules framed there under. The place for the arbitration shall be Chandigarh. Any dispute arising, thereafter, will be subject to the jurisdiction of the Courts at Chandigarh only.
