The applicants should have valid **PAN, GST & Digital Signature Certificate of Class-3.** The applicant/firm should not be blacklisted or included in negative list or terminated of their services in the past by any Scheduled Bank / PSU /Corporate body / Govt. Body. No partner / Proprietor of the applicant should have been a director / Partner / Proprietor in an entity that been blacklisted or included in negative list in the past by any scheduled Bank/PSU/Corporate body/ Govt. body. An undertaking / Certificate to this effect should be submitted in the application. If the Bank finds the undertaking / Certificate provided by the applicant to be false/forged at any time, including during the term of the empanelment (If empaneled), the applicant will be immediately disqualified / terminated by the Bank.

MINIMUM ELIGIBILITY CRITERIA FOR WORK PROFILE

1. Applicants should have experience in having successfully completed similar works of value as prescribed in (Annexure-B) for Central Govt. Department/State Govt. Department/ Semi Govt. Department/ PSUs/ Public sector Banks/ Public limited (Listed) Company, during the last 7 years ending on 30.06.2026. The information must be supported with the copies of Work Order and Satisfactory Completion Certificate, etc., proof of payment /Form 26 AS etc.
2. The essential eligibility criteria for the Civil Contractor and other relevant experience shall be as under.
 - (a) The firm should be a registered firm / company having valid GST registration, PAN, and other statutory registration as applicable. The contractor should have sufficient experience in executing construction works, structural and masonry works, flooring & finishing works, waterproofing works, doors, windows & fabrication, painting & polishing works, plumbing and sanitary works, external development works, repair and renovation works.
 - (b) The contractor must submit sufficient documentary evidence, work order and work completion certificates etc. meeting the above-mentioned criteria of similar works from the Central Govt. Dept/ State Govt. Dept/ Semi Govt Dept/PSU/Public Sector Banks/Public Limited (Listed) Company during last 7 years as on 30.06.2026. Work completion certificate is mandatory. Ongoing works/project will be not considered.
 - (c) Applicants should have minimum average annual turnover prescribed in minimum eligibility criteria as given in Annexure 'A' table during last 3 years ending on 31st March of the previous financial year (FY 2023-24, 2024-25, 2025-26).
 - (d) The bidder should submit a solvency certificate of 30% of the estimated cost from any Scheduled Commercial Bank in India as mentioned table. The Solvency Certificate should not have been issued prior to 6

months from the date of application.

- (e) The vendor should submit the MSME registration in the specific field for which empanelment has been applied, wherever applicable.
- (f) The empanelment of contractors in each category shall be considered purely on merits, performance of the contractor, verification of their credentials / inspection of work for quality, infrastructure feedback / confidential reports of the firms/applicant received from other employers etc. Hence, merely fulfilling the prescribed minimum prequalification criteria shall not entitle the contractor for their empanelment with SBI.
- (g) SBI reserves its right to empanel contractor as per its needs in each category. The applicant must fulfill the eligibility criteria for each Category of the work individually.
- (h) The empanelment of contractors shall be considered on merits within the sole discretion of SBI and cannot be claimed as right by the applicant and no correspondence shall be entertained by SBI in this regard.
- (i) The applicant should be bona-fide resourceful and well experienced contractor/firm and should not have been disqualified/ debarred/ terminated on account of poor or unsatisfactory performance/ blacklisted from any Government, Semi-government, PSU Bank, or any other organizations including any of the Offices/Branch of State Bank of India during last 7 years as on 30.06.2026.
- (j) The application of disqualified/ debarred/ blacklisted/ terminated agency/ contractor/ vendor on account of poor or unsatisfactory performance shall be summarily rejected and if such cases are found at a later stage, their empanelment will be cancelled.
- (k) The validity of the panel is 3 years from the date of approval by the Bank. However, the performance of all the empaneled contractors shall be reviewed periodically and the contractors with unsatisfactory performance shall be removed from the panel without notice and no

correspondence will be entertained in this regard. Such contractors shall not be eligible for next one empanelment process to be done by SBI. Thereafter, if they wish they can apply afresh for empanelment.

- (l) The panel of contractors will be valid for the entire Bhopal Circle (MP & CG) and contractors will be entitled to participate anywhere within these areas.
- (m) Empanelment procedure is to create a panel of Contractors for undertaking civil works. Mere empaneling does not guarantee any work allotment to the panel contractors. The work allotment is done through an online tendering process for its projects among the panel contractors. Therefore, the contractor will have to submit valid e-mail ID, Mobile no. and shall possess a valid Digital Certificate (suitable for online tendering) to enable the firms for participation in the online procurement/e-tendering.
- (n) SBI may choose to carry out physical inspection of works mentioned by the applicants in their application forms, in addition to calling for confidential reports from the respective employer/client/department to ascertain their capability and quality of works. The applicant shall agree and authorize SBI to obtain the confidential report from the clients of the applicant contractors, to obtain credit opinion from the Bankers and to verify the work executed by the contractors. If, during the physical inspection conducted by the Bank engineer / Officials, the quality of work, workmanship, timely completion of the project / work, or any adverse observations received from the client regarding the work or the contractor's conduct are found to be unsatisfactory to the Bank, the Bank reserves the right to reject the application for empanelment in the applicable project cost category or to downgrade the empanelment in the applicable project cost category. The decision of the bank shall be final and binding and no correspondence in this regard shall be entertained.
- (o) The contractors should be equipped with necessary infrastructure, machinery and tools, labour strength, etc. to carry out the Civil works.

- (p) Canvassing in any form including bringing influence from any person /agency /Officials /authorities shall lead to disqualification of the applicant.
- (q) The performance of all the empaneled vendors shall be reviewed by the SBI at periodical interval of every year or so and the contractors with unsatisfactory performance and those who do not respond to three consecutive tender enquiries of the SBI without informing any valid reasons will be debarred from the panel without notice and no correspondence will be entertained in this regard. Such contractors shall not be eligible for fresh empanelment in the SBI for next 3 years, thereafter, if they wish they can apply afresh for empanelment in prescribed format.
- (r) The contractor is required to furnish their PAN No, GSTIN Registration details of firm with GSTIN No. etc. to the SBI along with supporting documents. The contractor abides to submit the original invoices of materials purchased from the company/dealers etc. for the works whenever demand by SBI and contractor has no reservation for the same.
- (s) All the pages of application shall be duly signed with seal of firm by the contractors, else their application shall be summarily rejected.
- (t) Empanelment does not mean allotment of works/tenders.
- (u) The performance of all the empaneled Contractor/Vendors vendor shall be reviewed by the Bank periodically. In case of unsatisfactory performance, the Bank may at its discretion consider for de-paneling/ holiday listing the architectural/ consultancy firm or empanelment list.
- (v) The Vendors who are already on Bank's panel needs to apply afresh.
- (w) The applicant should have a registered office in Madhya Pradesh/ Chhattisgarh or if, not, they agree & confirm to open office/branch office shortly in future, if qualified in empanelment. Applicant will have to submit valid e-mail ID, cell no. and Digital Certificate to enable the firms for participation in the online procurement/e-tendering.

- (x) Civil contractor and their staff are expected to maintain “good behavior”, good conduct and avoid creating disturbances. If the agency is found violating these behavioral and ethical conditions than Bank will cancel the agency empanelment with immediate effect and suitable action will be taken.
- (y) The Bank shall have the right to ask for original tax invoices of all materials/few materials for the reference/audit/genuineness of materials and agency/consultant is bound to submit the same.
- (z) If agency/consultant fails to pay GST, other taxes and any other statutory obligation as per Govt norms, the Bank can immediately terminate their firm from the empaneled list and suitable action will be taken.
- (aa) Bank reserves the right to accept or reject any or all the applications without assigning any reason thereof and no correspondence will be entertained in this regard.
- (bb) Any amendments/ corrigendum for empanelment of contractors/ vendors shall be published in Bank’s website and e-tendering portal only. Therefore, applicants are requested to visit Bank’s website regarding modifications/ corrigendum issued till the last day for the submission of the applications.
