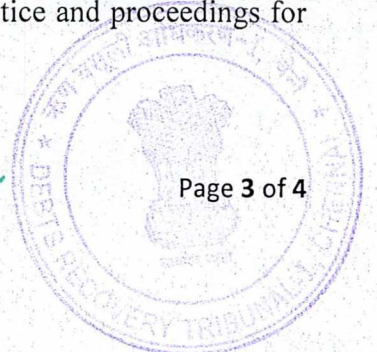

1. **CERTIFICATE HOLDER BANK MUST ENSURE:**
