It shall be the responsibility of the interested bidders to inspect and satisfy themselves about the property before submission of the bid.

The payment of all statutory / non- statutory dues, taxes, rates, assessments, charges, fees, GST etc., owing to anybody shall be the sole responsibility of successful bidder only.
