

NON-DISCLOSURE AGREEMENT

This Non-Disclosure Agreement (the "Agreement") is entered into as of [Date], by and between the State Bank of India (hereinafter referred to as "SBI"), with its Local Head Office at State Bank of India, Premises & Estate Department, Amaravati LHO, 2nd Floor, Gunfoundry, Abids, Hyderabad – 500001 and [Name of Bidder] (hereinafter referred to as the "Bidder"), with its principal office located at [Address].

WHEREAS, SBI, Amaravati LHO, has invited bids for the Construction of the Office Building for Amaravati Local Head Office and Other Outfits at Amaravati, Andhra Pradesh in EPC mode (the "Project"); WHEREAS, As part of the tender process, SBI through its Project Management Consultant (PMC) – Rdx Architects – intends to share certain 3D render images (hereinafter referred to as "Confidential Information") with the prospective bidders for better understanding of the project's design intent;

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereto agree as follows:

1. **Confidential Information.** The 3D render images and any other design-related information shared by SBI/PMC shall be treated as confidential and shall remain the sole property of SBI.
2. **Obligations of Non-Disclosure and Non-Use.** The Bidder hereby agrees to:
 - 2.1. Maintain the confidentiality of all such information and not disclose it to any third party without prior written consent of SBI.
 - 2.2. Use the Confidential Information solely for the purpose of preparing and submitting its bid for the Project.
 - 2.3. Not reproduce, circulate, or utilize the renders for any unintended or unauthorized purpose beyond the scope of this tender.
3. **Duration.** This Agreement shall commence on the date hereof and shall continue until the completion of the Entity's involvement in the Project, unless earlier terminated by either party with thirty (30) days written notice. NDA is valid until official inauguration of the project by SBI. The obligations of confidentiality shall survive the termination of this Agreement.
4. **Entire Agreement.** This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements, understandings, negotiations and discussions, whether oral or written, of the parties.
5. **Governing Law and Jurisdiction.** This Agreement shall be governed by and construed in accordance with the laws of India. The parties hereby submit to the exclusive jurisdiction of the courts located in Hyderabad, India, for the resolution of any disputes arising out of or in connection with this Agreement.
